**Starting Times:** 7:30 am shotgun start

**Format & Rules:** Four-Ball Stroke Play – Two competitors play as partners, each playing their own ball throughout the round. The team score for each hole is the lowest score of the 2 players.

**Eligibility:** All A-1, A-2, A-4, through A-24 & Life Member classification of the PGA in good standing at the time of the event. Also, PGA Assistants, PGA Apprentices, and LPGA Members are eligible to play. Each team must have at least one PGA Professional.

**Field:** 100 players/ 50 teams

**Entry Fee:** Until August 2<sup>nd</sup> \$150.00 per player  
On or after August 2<sup>nd</sup> \$175.00 per player

**Fee Includes:** **Entry Fee • Range & Balls • Carts • Breakfast • Lunch • Refreshments on Course • Gift Bags • Shuttle Bus Transportation from The Venetian to The Revere Golf Club (Roundtrip)**

***Tournament registration closes on Thursday, August 12, 2010 at 12:00PM***

**Payout:** The projected purse of \$7,000 is based on a field of 50 teams. The first place team wins \$2,000 and 20% of the field will be paid.

**Ties:** In the event of a tie for the Championship, a hole-by-hole play off will take place immediately after all scores have been confirmed. All other ties will split the purse.

## **Procedures & Information:**

### **Entry, Withdraw, Refund Policy**

Entries will be received until 12:00pm on Thursday, August 12, 2010. Any withdraws up until that time will receive a full refund. Any exceptions to the policy are at the discretion of the PGA Fall Expo Professional Challenge Cup Committee.

### **Format**

Four-ball Stroke Play – Two competitors play as partners, each playing their own ball throughout the round. The team score for each hole is the lowest score of the 2 players.

### **Pairing/Starting Times**

All pairing will be done by officials of The PGA of America on behalf of Reed Exhibitions. All pairing and starting time assignments are final and may not be appealed.

### **Eligibility**

All A-1, A-2, A-4, through A-24 & Life Member classification of the PGA in good standing at the time of the event. Also, PGA Apprentices, PGA Assistants, and LPGA Members are eligible to play. Each team must have at least one PGA Professional.

### **Distance Measuring Devices**

Distance measuring devices may be used. A player may not use a device that has the capability to obtain other information other than distance only.

### **Cart/Caddie Policy**

The player may walk or ride a cart during this tournament. Only players and/or caddies are allowed to ride in a cart. No spectator carts are allowed.

### **Tournament Payout**

The projected purse of \$7,000 is based on a full field of 50 start teams. If there is a full field of 50 teams, it is anticipated that the first place team in the tournament wins \$2,000 and 20% of the field will be paid. All results will be announced on August 17<sup>th</sup> at 4:00 p.m. on the show floor of the PGA Fall Expo at The Venetian.

### **Playoffs**

In the event of a tie for first place, there will be an on course sudden death playoff. The playoff will begin immediately after all scores have been confirmed. All other ties will split the purse.

### **Dress Code**

Female participants **must** wear slacks, culottes, walking shorts, or golf skirts which constitute acceptable clothing worn by women in connection with participation in professional golf tournaments. Male participants **must** wear slacks and participants should not wear shorts anywhere on club property. Jeans are not to be considered slacks. Any player not abiding by this policy may be subject to being removed from the tournament and loss of entry fee. Players or spectators and threats of violence are not permitted. Players violating the Code of Conduct may be subject to being removed from the tournament and loss of entry fee.
